BRIEF DESCRIPTION:

This project will convert existing high voltage series street lighting circuits to low voltage multiple circuits (approximately 352 street lights) by replacing conduit, wires and luminaires (no pole replacement). Most of the conduit installation will be on hilly streets where there is no sidewalk. The project area is scattered throughout six general areas in Hollywood Hills and Beverly Hills, in the vicinity of: 1) Hollywood Bl and Crescent Heights Bl, 2) Sunset Plaza Dr between Viewmont Dr and Pinetree Pl, 3) Hollywood Bl and Queens Rd, 4) Doheny Dr and Sierra Mar Dr, 5) Fareholm Dr and Fairfax Ave, and 6) Coldwater Canyon Dr and Heather Rd.

Financing for this project is from the Municipal Improvement Corporation of Los Angeles (MICLA).

This project will not result in an increase to existing Street Lighting Maintenance Assessments. A Proposition 218 ballot proceeding is not required.

THE CONTRACTOR'S LICENSE CLASSIFICATION REQUIRED FOR AWARD IS **"C-10" or "A"**.
