**BRIEF DESCRIPTION:**

This project will convert existing high voltage series street lighting circuits to low voltage multiple circuits (approximately 408 street lights) by replacing conduit, wires and luminaires (no pole replacement). A portion of the conduit installation will be on streets where there is no sidewalk. The project is spread among seven areas: Tujunga, Beverly Grove, Hollywood Hills, Valley Village, Studio City, North Hollywood, and North of Beverly Hills. Financing for this project is from the Municipal Improvement Corporation of Los Angeles (MICLA).

This project will not result in an increase to existing Street Lighting Maintenance Assessments. A Proposition 218 ballot proceeding is not required.

THE CONTRACTOR'S LICENSE CLASSIFICATION REQUIRED FOR AWARD IS **"C-10" or "A"**.
