BRIEF DESCRIPTION:

The project will replace street lighting conduit to facilitate future conversion of the existing street lighting system from high voltage to low voltage. The project includes installation of conduit and pullboxes in the vicinity of 1) Spring St between Temple St and Cesar E Chavez Ave, 2) Alameda St between Fwy 101 and North Main St, and Cesar E Chavez Ave between Alameda St and 600' S/O Alameda St, 3) Olive St between 7th St and 5th St, and 6th St between Olive St and Spring St, 4) Streets bounded by Gayley Ave, Le Conte Ave, Levering Ave, Strathmore Dr and Veteran Ave, 5) Streets in the vicinity of San Marco Dr and San Marco Cir, 6) Streets in the vicinity of La Granada Dr and Holly Dr, 7) Holly Dr from Bryn Mawr Dr to 300' N/O Bryn Mawr Dr, and Bryn Mawr Dr between Holly Dr and Alcyona Dr, 8) Streets in the vicinity of Bronson Hill Dr and Tuxedo Ter.

Financing for this project is from the Municipal Improvement Corporation of Los Angeles (MICLA).

This project will not result in an increase to existing Street Lighting Maintenance Assessments. A Proposition 218 ballot proceeding is not required.
