BRIEF DESCRIPTION:

This project will convert the existing series street lighting system to a low voltage lighting system by replacing 260 luminaires and 10 soffits with LED fixtures. Work also includes the installation of new conduit and wires. In addition, the project will include the installation of technology to provide real-time reporting of light outages/failures. The project area is primarily along Ventura Blvd. between Amigo Ave. and White Oak Ave, and between Densmore Ave. and Calhoun Ave.

Financing for this project is front funded by the Public Works Trust Fund, then later reimbursed by the Federal Highway Administration.
